

# Meet our 2025 Board of Directors and staff



## Cynthia Kanner, Executive Director

Cynthia Kanner is our first executive director and brings a broad spectrum of experience to the position, most recently 15 years with Environmental Defenders of McHenry County as its executive director for the last four years.

She served as director of communications and marketing and as a consultant for Lowell Observatory in Flagstaff, Arizona, and as executive director of World Affairs Council of Washington, D.C.

She holds a Bachelor's degree in International Comparative Studies from Duke University. Kanner has been a long-time supporter of conservation and environmental organizations locally as well as statewide and serves on the board of directors of the Food Shed Co-op, a cooperative grocery store breaking ground in McHenry County in 2023.

Her yard received the designation of Conservation@Home through the Land Conservancy of McHenry County and has both a native prairie and native woodland garden as well as several old bur oak trees. She is a former stream monitoring educator with Friends of the Fox River and is a river guide on the Fox.



# Brook McDonald, President

#### The Conservation Foundation

Brook McDonald has been President and Chief Executive Officer for The Conservation Foundation since 1996. He chaired the DuPage River Coalition from 1989 to 1995, and is past chairman of the DuPage River Watershed Ecosystem Partnership. He is principal author of Illinois's first citizens stream monitoring manual published in 1990.

He served on the Warrenville Planning Commission and

Zoning Board of Appeals from 1993-1996, and sat on the Board of Directors for the National Association for Interpretation from 1994 to 1998. He also served on the board of the Illinois Environmental Council from 1998 to 2001, served as a member of the Kendall County Extension Unit's Advisory Council, and is a past member of the board for the Campaign for Sensible Growth.

He served more than 10 years as an appointed member of the DuPage Environmental Commission, served as chairman of the DuPage County Trails Maintenance Task Force, and as the chairman of the DuPage Green Government Council.

He worked as Public Affairs Director for the Forest Preserve District of DuPage County, Manager of Interpretationn and Natural Resources for the Wheaton Park District, a naturalist for Metro Parks of Columbus and Franklin County, and as a Stream Monitoring Coordinator for the Ohio Scenic Rivers proggram for Ohio Department of Natural Resources.



### Jim Johannsen, Vice President

#### Jo Daviess Conservation Foundation

Jim Johannsen is the Director of Land Conservation for Jo Daviess Conservation Foundation (JDCF). His day-to-day work is focused on two program areas: Land Preservation and Land Stewardship.

In his work with JDCF's Land Preservation program, Jim leads acquisition of land and conservation easements. In the Land Stewardship program, he leads a team of four that maintain over 2,000 acres of land owned by JDCF across 12 preserves.

He holds a B.A. in English and Religion from Augustana College and a Master's of Public Administration from the University of Illinois – Springfield. Jim is currently serving on the board of directors of the Natural Areas Association (NAA), a national nonprofit organization. Jim also serves as Treasurer for NAA.

Jim volunteered for the PSCC Executive Director Hiring Committee and also serves on the PSCC Board Development Committee.



# Paul Botts, Secretary

#### The Wetlands Initiative

Paul Botts has been President and Executive Director of the Wetlands Initiative since 2011. In that capacity he's served on a variety of statewide and regional councils such as Vital Lands Illinois, the Chicago Wilderness Executive Council, Illinois The Beautiful, and PSCC starting in 2021.

Previously, he was Director of Chicago Programs at the Gaylord and Dorothy Donnelley Foundation. Paul served in operations and development roles at The Nature Conservancy of Illinois during

the 1990s, and spent a few years as managing director of a professional theater company in Chicago. A Chicago native, retired local musician, and recovered newspaper reporter, Paul now lives with his family in the city's South Loop.



### Erin Herbez, Treasurer

#### ParkLands Foundation

Erin Herbez is Administrative Director for ParkLands Foundation. She was born in New Orleans, Louisiana, and remained there through the first two years of college. She completed her Bachelor's in Ecology, Evolution and Conservation from the University of Texas at Austin.

## Fran Harty

#### retired

Fran Harty is retired from the Illinois Department of Natural Resources. He is a co-founder and past president of Prairie State Conservation Coalition.

He is co-founder and current treasurer for the Friends of the Illinois Nature Preserves. He helped write and pass the Illinois Prescribed Fire Act.

Fran helped establish the 19,000-acre Midewin National Tallgrass

Prairie and add 9,000 acres to the Upper Mississippi River Wildlife Refuge at the Savanna Army Depot. He secured a \$1-million-dollar donation to support the TNC/Forest Service Volunteer program at Midewin.

Yes, there's more! He wrote the Illinois Natural Areas Stewardship Act, is an advisor to the Illinois Nature Preserves Commission, and is a past president of the Natural Areas Association. He also developed the Division of Natural Heritage's Natural Heritage Residency Program.

#### Clifftop NFP

James (Jim) Hill has provided diverse professional conservation and life quality services in Illinois for over 40 years. He earned a BS in Forestry from Southern Illinois University – Carbondale in 1982. #### Great Rivers Land Trust

Alley Ringhausen has served as the Executive Director of Great Rivers Land Trust since 2001. He joined Great Rivers Land Trust in 1999 as Developer and Manager of the Piasa Creek Watershed Project. Under his leadership, Great Rivers Land Trust has protected thousands of acres of property in Illinois and Missouri; developed wetlands, reduced erosion, planned parks, restored streams; and partnered with numerous organizations on a wide variety of conservation projects.
